Madison weights will be used for all age groups except Cadets and Juniors. Weigh-ins April 13th from 7:45 AM to 9 AM (except for Open wrestlers registration from 9:00 to 12:00.) Open weigh-in's from 11:00 to 12:00. Wrestling will start at or around 10:00am for Elementary through Juniors; Open wrestlers will start wrestling about 12:30. Bouts will be 3 periods (2 minutes for Juniors and Open, 1.5 minutes for Cadets and Schoolboys, and 1 minute for Bantam, Midget and Novice). Seeding will be done by blind draw but matches will be paired using double elimination line brackets. Medals for the top three finishers in each class. Four full mats will be used for this competition. During weigh-ins, all competitors will be inspected for skin rashes. Wrestlers with skin rashes will not be allowed to compete unless they have a <u>current</u> doctor's excuse saying they are under treatment, are not contagious as of a specified date and are cleared to wrestle. Tournament officials reserve the right to refuse entry to questionable cases.

A 2007-2008 USA Wrestling card <u>MUST</u> be shown at registration. If you don't have a card, you may purchase one the day of the tournament for \$35.00. If you are under 18 years of age, a parent <u>MUST</u> sign this registration form for it to be processed. This is an insurance requirement, and there will be **no** exceptions made. If a parent is not accompanying you to this tournament, please download the application form from the link for 'important forms' on <u>www.usawct.org</u>, and complete it with parent's signature and bring it to the tournament.
