

# USAWCT Winter Folk Style Tournament Agreement for Non Connecticut USA Chartered Wrestling Clubs

As a Non Connecticut USA Chartered Wrestling Club we agree to follow to the best of our ability the following rules of USAWCT:

All coaches will be required to have current USA Wrestling coaches card , which **must be displayed on the coaches upper body when coaching alongside the mat.**

- Only the Director of a Non Connecticut Chartered Wrestling Club, will be allowed to preregister wrestlers, therefore out of state wrestlers must be associated with a Non Connecticut Chartered Wrestling Club.
- As a Non Connecticut USA Chartered Wrestling Club, we agree to pay for all wrestlers that we have pre-registered on the USAWCT web site, that do not show up for check in. If the Non Connecticut USA Chartered Wrestling Club Director is able to notify the Tournament Director the day before the tournament, that a wrestler should be scratched from that tournament, the Tournament Director will normally remove the wrestler from their pre-registered list, in that case there will be no charge to the Non Connecticut Chartered Wrestling Club for the scratched wrestler, which is also the case with Connecticut Chartered Wrestling Clubs.
- As a Non Connecticut USA Chartered Wrestling Club, we agree to provide proof of our wrestlers current membership (hold a current Sept 1st to August 31 valid USA Wrestling Card). This proof can be copies of the USA wrestling card or an email from USAW National office listing the wrestler, DOB and mailing address; this information must be e-mailed to USAWCT's Membership Director Sarah Jadach, [sjadach23@aol.com](mailto:sjadach23@aol.com) at least five days prior to the tournament date your club wants to participate in. Only the data base on our web site will be used to register for tournaments, this will ensure that all wrestlers are proper USA wrestling members and allow for a uniformed format to process entries.
- Tournament registration fees are \$17/ pre-registration. All Non Connecticut and Connecticut club directors are to collect their wrestlers registration fees and pay the tournament director the morning of the tournament. Payments should not be made with more than one (1) check. There are NO refunds for no-shows.
- Non Connecticut Chartered Clubs that are able to register on line will also comply with the standard weigh in requirements.
- Any athlete with a suspect skin condition, must be cleared by the trainer at the tournament prior to the athlete being admitted into the tournament.
- You must check the USAWCT.org web site to get the details for each tournament.

We understand that if we fail to follow the rules listed above, will result in our Club losing the privilege of Registering our Club wrestler's on-line at the USAWCT web site for the USAWCT tournaments.
